Dear Homeland Security and Emergency Management Partners,

FEMA's Grant Programs Directorate (GPD) is hosting 3 **one-hour trainings** in Spanish on the federal procurement rules applicable to recipients and subrecipients when purchasing in support of a FEMA grant award. These virtual webinars will be facilitated by the Procurement Disaster Assistance Team (PDAT) and FEMA's Office of Chief Counsel (OCC) and will be offered between April and June 2022. The trainings are 1-hour in length and will cover a variety of procurement under grant concepts by detailing the 10 most frequent procurement noncompliance issues as reported by the Department of Homeland Security's Office of the Inspector General (OIG) and providing available resources to help avoid these mistakes.

El Directorado de Programas de Subvenciones de FEMA (Grant Programs Directorate o GPD) estará llevando a cabo 3 adiestramientos en español de una hora sobre las reglas de contratación aplicables a receptores y subreceptores cuando estos llevan a cabo compras bajo una adjudicación de una subvención de FEMA. Estos adiestramientos virtuales serán facilitados por el Equipo de Asistencia para la Contratación con Fondos de Desastre (Procurement Disaster Assistance Team o PDAT) y la Oficina del Asesor Legal de FEMA (Office of Chief Counsel u OCC) entre mayo y julio 2022. Los adiestramientos tendrán una duración de 1 hora y cubrirán una variedad de conceptos atados a las adquisiciones bajo subvenciones, detallando los 10 problemas más comunes de incumplimiento contractual, según informado por la Oficina del Inspector General (OIG). Además, se proveerán recursos disponibles para ayudar a evitar estos errores.
