- Mission Statement- must be on letterhead.
- Investment justification (IJ)- for each facility apply for funding.
  - Please read and follow all instructions on the attached IJ form.

## **FY2023 NSGP Application**

Eligibility requirements apply.

If you receive *any* public tax dollars for general operation- you may not qualify- eligibility links can be located on <a href="http://www.datacounts.net/nsgp">http://www.datacounts.net/nsgp</a>

- Unique Entity Identifier (UEI) number is required.
  - o Register for a UEI at <a href="http://www.sam.gov">http://www.sam.gov</a> or to check on the status.
- The Investment Justification form (IJ), If you started working with a previous version, please utilize the latest FY23 IJ form attached or posted on http://www.datacounts.net/nsgp.
  - IJ's must be submitted as an Adobe PDF
  - Recommend using a word document to collect the information to assist with spell check and grammar.

- The facility(s) you are applying for must be completed (not under construction), occupied and operational by the time of application and located in Kansas.
  - This opportunity is not for building or expanding a new facility and is strictly for security enhancements.
  - Max per site remains \$150,000 for up to 3 sites- No more than \$450,000 per organization per application year.
  - A separate application-Risk Assessment-Mission Statement must be submitted per site.
- Bonus points will be given to new applicants/organizations.
- Bonus points will be given for Underserved Communities
  - Underserved Communities are designated by FEMA.

Our office is committed to assisting eligible applicants receive this security enhancement funding and look forward to receiving your complete application packets by the deadline.
