Purchasing Under FEMA Awards Training Schedule: January – June 2024

- Standard Procurement Under Grants (PUG) Training Provides an overview of the federal procurement under grants rules for recipients and subrecipients when purchasing under a FEMA grant.
- Exigency or Emergency (E&E) Training Educates recipients and subrecipients on the federal procurement under grants rules applicable when purchasing during exigency or emergency circumstances.
- Prepare Before a Disaster Focuses on contracting actions recipients and subrecipients can take to prepare before a disaster strikes and addressing the procurement rules applicable during these times.
- **Procurement Under Grant (PUG) Training- Mitigation Grants** Provides an overview of the federal procurement under grant rules for recipients and subrecipients when purchasing under a FEMA mitigation grant.

This training is appropriate for FEMA award recipients and subrecipients, including state, local, tribal, and territorial government personnel; nonprofit organization staff; eligible private entities; and other non-Federal entities. This training is also appropriate for FEMA staff.
